BLENDED INTENSIVE PROGRAMME

WHAT IS A BLENDED INTENSIVE PROGRAM

- IT'S A PROGRAM THAT INTRODUCES A NEW WAY OF LEARNING AND TEACHING THROUGH MORE FLEXIBLE FORMS OF MOBILITY
- IT COMBINES PHYSICAL MOBILITY WITH A MANDATORY VIRTUAL COMPONENT

STUDENTS REQUIREMENTS AND RULES

- STUDENTS ENROLLED AT A HEI IN A EU MEMBER STATE, OR IN A THIRD COUNTRY ASSOCIATED WITH THE PROGRAMME, OR IN A THIRD COUNTRY NOT ASSOCIATED WITH THE PROGRAMME
- MINIMUM NUMBER OF PARTICIPANTS: **15** (EXCLUDING TEACHING STAFF)
- MAXIMUM NUMBER OF PARTICIPANTS: **20**
- DURATION OF PHYSICAL MOBILITY: **FROM 5 TO 30 DAYS**
- VIRTUAL COMPONENT IS MANDATORY (NO MINIMUM TIME RANGE REQUIRED)
- ACQUISITION OF MINIMUM 3 ECTS, INCLUDED IN BOTH THE PHYSICAL AND VIRTUAL MOBILITY

STUDENTS GRANT

EACH UNIVERSITY MAY PROVIDE THE GRANT **TO SUPPORT PHYSICAL MOBILITY** WITHIN THE FRAMEWORK OF THE ERASMUS KA31 FUNDING ALREADY ALLOCATED TO IT AND INTENDED FOR STUDY MOBILITY.

THE GRANT IS CALCULATED ON A DAILY BASIS:

- **70 € PER DAY** UP TO THE 14° DAY OF PHYSICAL MOBILITY
- **50 € PER DAY** UP TO THE 15° TO THE 30° DAY OF PHYSICAL MOBILITY
- INDIVIDUAL SUPPORT MAY ALSO COVER ONE TRAVEL DAY BEFORE AND ONE TRAVEL DAY AFTER THE ACTIVITY ABROAD.

THE GRANT IS COVERED BY THE SENDING UNIVERSITY. STUDENTS FROM THE INSTITUTION PHYSICALLY HOSTING THE BIP MAY PARTICIPATE BUT ARE NOT ENTITLED TO RECEIVE THE GRANT.

2 POSSIBLE CASES

CASE A – ORGANIZATION AS BOTH HOST SITE AND COORDINATOR OF THE BIP

CASE B – PARTICIPATION AS A PARTNER IN A BIP COORDINATED BY A FOREIGN UNIVERSITY

CASE B – PARTICIPATION AS A PARTNER IN A BIP COORDINATED BY A FOREIGN UNIVERSITY

1. PROVISION OF MOBILITY FUNDS FOR STUDENTS OR TEACHERS PARTICIPATING IN BIPS

2. SUPERVISION AND SIGNING OF THE MULTILATERAL AGREEMENT

3. SELECTION OF STUDENTS (BY DEPARTMENTS/SCHOOLS)

4. PAYMENT OF THE SHORT-TERM MOBILITY GRANT

5. ENTERING DATA CONCERNING STUDENTS MOBILITIES INTO THE BM

6. GRANTS FOR THE PARTICIPATION OF TEACHING AND ADMINISTRATIVE STAFF

MAIN STEPS AND PROCEDURES (TO BE SHARED AND TO BE CARRIED OUT BY ALL THE PARTIES INVOLVED)

1. TOPIC IDENTIFICATION
2. SIGNATURE OF THE MULTILATERAL AGREEMENT
3. SETTING UP OF THE MAIN TIMELINES AND DEADLINES
4. CREATION AND PUBLICATION OF A CALL FOR THE BIP
5. CALLS AMONG THE INSTITUTIONS TO SHARE THE STATE OF THE ART AND FOR FOLLOW UP
6. STARTING OF THE BIP

MAIN STEPS AND PROCEDURES FOR PARTNER INSTITUTIONS INVOLVED

1. PUBLICATION OF THE CALL, FOR THE PARTICIPATION OF STUDENTS AND STAFF
2. CHECKING THE AVAILABLE FUNDS TO FUND STUDENT AND STAFF MOBILITY PROGRAMS
3. MINIMUM NUMBER OF STUDENTS PER INSTITUTION: 5
4. DECISION ABOUT THE DEADLINE FOR SHARING THE NUMBER OF PARTICIPANTS (STUDENTS) AND THE FOLLOWING TIMELINES FOR OUR CALL

ACTIVITIES AND GRANTS

ACTIVITIES FUNDED BY THE HOME INSTITUTION: TRAVEL AND ACCOMMODATION (KA131 ERASMUS+ GRANT)

ACTIVITIES FUNDED BY THE HOSTING INSTITUTION AND COORDINATOR OF THE BIP:

- WEEKLY/MONTHLY TRAVEL CARD
- CULTURAL VISITS
- LUNCHESES/DINNERS TOGETHER AT THE UNIVERSITY

...OTHER ACTIVITIES THAT WILL BE COMMUNICATED AND SHARED OVER TIME

REPORT OF THE ACTIVITIES

THE PARTNER INSTITUTIONS TAKING PART IN THE BIP WILL PROVIDE THEIR INTERNATIONAL RELATIONS OFFICE/ERASMUS OFFICE WITH ALL THE INFORMATION ON:

- DURATION OF THE BIP
PHYSICAL MOBILITY AND VIRTUAL COMPONENT

- NUMBER OF PARTICIPANTS (STUDENTS AND STAFF)

THE OFFICE IN CHARGE WILL INSERT ALL THE INFORMATION ABOUT EACH PARTICIPANT AND THE KIND OF MOBILITY HE/SHE IS INVOLVED IN, IN THE BENEFICIARY MODULE (**EU PORTAL**)
